### **Profession-wide Awards and Honors**

#### **REMINGTON HONOR MEDAL**

The Remington Honor Medal, named for eminent community pharmacist, manufacturer, and educator Joseph P. Remington (1847-1918), was established in 1918 to recognize distinguished service on behalf of American pharmacy during the preceding years, culminating in the past year, or during a long period of outstanding activity or fruitful achievement.



Stephen W. Schondelmeyer, BS, PharmD, MPA, PhD, FAPhA, is a professor of pharmaceutical economics at the University of Minnesota's College of Pharmacy. He holds the Century Mortar Club Endowed Chair in Pharmaceutical Management and Economics and has served for 24 years as department head for Pharmaceutical Care and Health Systems. He received his BS in pharmacy from the University of Missouri-Kansas City, PharmD and ASHP residency at University of Kentucky, and masters in public administration and PhD in pharmaceutical administration at The Ohio State University along with a National Endowment for Humanities Fellowship in history of medicine.

He has conducted economic and public policy research on roles of pharmacists and pharmaceuticals in society for over 50 years. In 1991, he founded, and continues to direct, the PRIME Institute, an independent research organization at the University of Minnesota. His research has influenced many key policy areas, including prescription drug access and affordability, drug price competition, pharmacists' compensation and workforce trends, and policy to reduce drug shortages and to improve drug supply resilience. He has conducted research for CMS, GAO, FDA, the Congressional Office of Technology Assessment, the U.S. Senate Special Committee on Aging, AARP, the pharmaceutical industry, and pharmacy associations.

Schondelmeyer has effectively presented to policymakers at state, national, and international levels. He has testified before the U.S. Congress more than 25 times, to more than 20 state legislatures, and served as an expert witness in more than 85 lawsuits to increase availability and affordability of prescription drugs. He was appointed to the Prescription Drug Payment Review Commission to advise Congress on the outpatient drug program of the Medicare Catastrophic Coverage Act. His work is widely recognized as an objective and credible source of policy analysis and has become well-known not only to those within pharmacy, but also to those outside of the profession (i.e., policymakers, public media, other health professions, PBMs and insurers, the pharmaceutical industry, consumer advocacy groups, and others).

Schondelmeyer's education, experience, and background have provided him with a unique understanding of the complex and technical issues leading to dramatic changes in the pharmaceutical marketplace. His work experience has encompassed activities in practice, academia, professional associations, and state and federal government. He has received a number of national honors and awards including APhA's Tyler Prize for Stimulation of Research, the APRS Research Achievement Award in Pharmaceutical Sciences, and the Hubert H. Humphrey Award.

#### **HUBERT H. HUMPHREY AWARD**

The Humphrey Award, named for the noted pharmacist, longtime APhA member, and public servant (senator from Minnesota and U.S. vice president), was established in 1978 to recognize APhA members who have made major contributions in government and/or legislative service.



Nicole Chopski, PharmD, ANP, serves as the health professions bureau chief for the Idaho Division of Occupational and Professional Licenses, overseeing 23 health-related boards and committees. She also acts as the executive officer for the Boards of Medicine, Nursing, and Pharmacy. Chopski's primary role is to promote, preserve, and protect the health, safety, and welfare of Idaho's citizens through effective collaboration with key partners and ensuring compliance with Idaho state regulations.

Raised and educated in Pocatello, ID, Chopski earned her doctor of pharmacy degree from Idaho State University College of Pharmacy in 1997. She was a certified geriatric pharmacist for 20 years and served

as a hospital pharmacist at Portneuf Medical Center for 21 years. In 2006, she completed Purdue University College of Pharmacy's program in nuclear pharmacy and, with partners, opened a nuclear pharmacy in Southeast Idaho. Chopski was appointed to the Idaho Board of Pharmacy by the governor in 2007; she served on the board for 12 years before becoming its executive director in 2019.

In her downtime, Chopski enjoys riding her Harley Davidson motorcycle and actively participates in the local POW\*MIA Awareness Association and the National League of POW/MIA Families.

#### GOOD GOVERNMENT PHARMACIST-OF-THE-YEAR AWARD

The award, established in 1990, recognizes an individual pharmacist who actively contributes to the community through their involvement in the political process.



**Ken Kunke, PharmD,** graduated from the University of Iowa College of Pharmacy in 2003 and soon relocated to Nevada. He worked in community pharmacy until early 2019, excelling in building high-performing teams, serving as a market trainer, delivering exceptional patient care, and improving operational efficiency across his organization's pharmacies. During this time, he was passionate about precepting up to 10 students annually, giving back to the profession he holds dear.

In early 2019, Kunke transitioned to academia as the director of experiential education at Roseman University, where he also serves as an associate professor of pharmacy practice. In 2020, recognizing

a critical need, he founded the Nevada Pharmacy Alliance (NPA). At the time, Nevada was the only state without a pharmacy association affiliated with APhA and the National Alliance of State Pharmacy Associations. NPA's mission is to connect, educate, and advocate for the pharmacy profession to optimize patient care and advance public health.

As NPA's executive director, Kunke manages daily operations and spearheads impactful advocacy efforts. Under his leadership, Nevada pharmacists have secured recognition as providers under Nevada Medicaid, expanded their ability to bill for clinical services, and benefited from streamlined pathways for entering into collaborative practice agreements. Landmark legislation supported by NPA has enabled pharmacists to dispense hormonal contraceptives without a prescription and to prescribe medications for HIV prevention and OUD.

Looking ahead to future legislative sessions, Kunke is enthusiastic about NPA's plans to advocate for bills that will further expand pharmacists' clinical service capabilities and ensure fair reimbursement for both dispensing medications and delivering clinical care.

#### **HONORARY MEMBERSHIP**

Honorary membership in the American Pharmacists Association is conferred by the APhA Board of Trustees upon individuals, either within the profession of pharmacy or outside of it, whose activities and achievements have had a significant impact on public health, the profession, and its practitioners.



**Steve Zigler, MS, PhD,** is the chief scientific officer for Siemens PETNET Solutions in Knoxville, TN. In his 30+ year career, he has played a pivotal role in the approval and commercialization of PET radiopharmaceuticals, including the first FDA approval of a PET radiopharmaceutical in a hospital setting. These efforts helped establish safe manufacturing standards for this class of products and catalyzed the evolution of a nationwide network of distribution facilities for PET radiopharmaceuticals.

Throughout his career, Zigler has cultivated close connections between pharmacy practice and drug manufacturing. He is a volunteer on the USP committee of experts where he focuses on

chapters and monographs for PET radiopharmaceuticals and nonradioactive kits used in the preparation of non-PET radiopharmaceuticals. His recent efforts led to the formation of a USP panel of nuclear pharmacists for the development of a new chapter for the preparation, compounding, dispensing, and repackaging of radiopharmaceuticals. These efforts promise to end decades of conflicting practice standards for nuclear pharmacy.

Zigler is a founding board member and currently co-director of the Coalition of PET Drug Manufacturers, a not-for-profit organization dedicated to the safe manufacturing of PET radiopharmaceuticals under FDA regulation. With 32 academic and commercial members across 100+ manufacturing facilities, the coalition's efforts have fostered effective communications with FDA related to good manufacturing practice regulations and marketing authorization applications.

Zigler's work at PETNET has focused on the commercialization of PET radiopharmaceuticals, where he was instrumental in the development of the first commercial generic drug approval for [F18]FDG, the most widely used PET radiopharmaceutical in the United States. He is an active committee member in the Society of Nuclear Medicine and Molecular Imaging and holds five patents. He has published numerous manuscripts and posters, as well as book chapters in the seminal textbook on nuclear pharmacy.

#### **HONORARY PRESIDENT**

Honorary president of the American Pharmacists Association is conferred by the association upon a member who has made significant contributions to the association.



Anne L. Burns, BSPharm, RPh, FAPhA, is currently president of Pharmacy Horizons, LLC. For 25 years prior, she worked at the American Pharmacists Association, most recently serving as vice president, professional affairs. In this capacity, she was responsible for the association's strategic practice initiatives focused on advancing pharmacists' patient care service delivery, payment for pharmacists' services, interprofessional collaboration, health information technology, health care quality, and addressing the opioid epidemic. In 1999, she guided the launch of the APhA/ASHP partnership to accredit community pharmacy residency programs and implemented a multifaceted approach to facilitate the growth of these

programs. She led the Joint Commission of Pharmacy Practitioners' development of the Pharmacist Patient Care Process and Medication Management Services Definition, co-led the creation of the APhA/NACDS Medication Therapy Management Core Elements Service Model, and contributed to the formation of the Pharmacy Health Information Technology Collaborative. She has served on many boards, coalitions, and workgroups, including the Board of Directors for the Pharmacy Quality Alliance and the Council on Credentialing in Pharmacy, the National Advisory Board for the National Rx Drug Abuse and Heroin Summit, the National Academies of Medicine Action Collaborative on Combatting the U.S. Opioid Epidemic, the CDC Opioid Guidelines Workgroup, the Pharmacy HIT Collaborative Workgroup on Professional Service Claims and Codes and the Ohio State University (OSU) College of Pharmacy Dean's Corporate Council. She has received several awards, including the APhA Community Pharmacy Residency Lifetime Achievement Award, the OSU College of Pharmacy Distinguished Alumni Award, and the OSU College of Pharmacy Lifetime Achievement Award.

Burns joined APhA in 1997. Prior to working at APhA, she served on the faculty at the OSU College of Pharmacy for 13 years. She received her BS in pharmacy from OSU and completed the Wharton Executive Management Program for Pharmacy Leaders.

#### **GLORIA NIEMEYER FRANCKE LEADERSHIP MENTOR AWARD**

This award recognizes an APhA member who has promoted and encouraged pharmacists to attain leadership positions within pharmacy through example as a role model and mentor. The pharmacist for whom the award is named-Gloria Niemeyer Francke, PharmD-personally exemplified the award's criteria. Francke, 1986 APhA honorary president and 1987 Remington Honor medalist, inspired and mentored future leaders throughout her illustrious pharmacy career.



Tina Penick Brock, BA, BSPharm, MS, EdD, is a pharmacist and the director of the Collaborative Practice Centre in the University of Melbourne's Faculty of Medicine, Dentistry, and Health Sciences in Melbourne, Australia. She is an educational activist with a fervent commitment to harnessing the transformative power of collaboration to advance health globally.

Brock started her pharmacy career at Medical Center Pharmacy in her hometown of McComb, MS. From that auspicious launching point, she moved into academic leadership roles at the University of North Carolina at Chapel Hill, University College London, University of California San Francisco, Monash

University, and the University of Colorado. She has also worked across all six WHO regions via the nongovernmental organization Management Sciences for Health. Brock currently serves on the WHO Academy Advisory Group of Lifelong Learning in Health. She is a fellow of APhA, the International Pharmaceutical Federation, and the National Academies of Practice.

Brock considers mentoring to be her true north. She's benefited greatly from it and is committed to ensuring that others have that support, too. No matter where she is, Brock's most treasured asset is her network of mentees around the world. It's through them that she stays passionate for the hard work of systems change. She is also grateful to still learn from them about emerging areas such as climate change and health, the potential uses of AI in health, equity and justice, allyship, global partnerships, and more.

#### H.A.B. DUNNING AWARD

The purpose of the award is to recognize an exemplary contribution to APhA and the practice of pharmacy by a pharmaceutical manufacturer, provider of support products or service, or other entities such as wholesalers, chain corporations, etc. The H.A.B. Dunning Award was established in 1982 to honor the former chair of the Board of Hynson, Westcott and Dunning of Baltimore, who as a longstanding APhA leader was instrumental in the funding and building of the APhA headquarters building in Washington, DC.

#### **DISTINGUISHED FEDERAL PHARMACIST AWARD**

Established in 2002, the Distinguished Federal Pharmacist Award is the association's premier award to recognize pharmacists who have distinguished themselves and the profession by outstanding contributions in federal pharmacy practice that have resulted in a significant improvement in the health of the nation and/or the population they serve.



CAPT Bridgette M. Faber, PharmD, MS, attended the University of Wisconsin–Madison where she received a Bachelor of Science in pharmacy and was commissioned as an ensign in the United States Navy in 1995. In 2004, she earned her doctor of pharmacy degree from Idaho State University. Selected to attend full-time duty under instruction, she received a masters in pharmacy and an American Society of Health Systems Pharmacists Accredited Specialized Residency in Health System Pharmacy Administration at the University of Wisconsin in 2005. In 2013, she completed a Clinical Informatics Fellowship at the Department of Defense/Department of Veterans Affairs Interagency Program Office.

Her tours of duty include the National Naval Medical Center, Bethesda, MD; the Office of the Attending Physician, Washington, DC; Naval Hospital, Naples, Italy; Naval Medical Center Portsmouth, Portsmouth, VA; the Captain James A. Lovell Federal Health Care Center in North Chicago, IL; and the Defense Health Agency, Falls Church, VA. She is currently the pharmacy consultant to the Navy surgeon general and pharmacy specialty leader, as well as the deputy director for clinical operations, standards and policy at the Bureau of Medicine and Surgery.

Faber's notable achievements include serving as the subject matter expert developing pharmacy interoperability solutions where she testified to members of Congress, House/Senate Armed Service Committee staffers, and senior policy advisors for DoD and VA Health Affairs on quality control measures and patient safety. She developed a Pharmacy Operational Readiness Training program providing new pharmacists with basic inpatient and expeditionary knowledge and she implemented an innovative coronavirus pharmacy plan, upgrading a pharmacy call center to accommodate a threefold increase in calls and establishing a drive-through pharmacy that handled over 1,500 cars daily. As the chair of the Navy Pharmacy Advisory Board, she was responsible for optimizing the delivery of the pharmacy benefit for 9.2 million TRICARE beneficiaries worldwide.

#### **DISTINGUISHED NEW PRACTITIONER AWARD**

The Distinguished New Practitioner Award was established in 2010 to recognize an individual new practitioner who has demonstrated distinctive achievements in mentorship, service, and commitment to the profession of pharmacy.



MAJ Cody R. Morcom, PharmD, BCPS, is the chief, Satellite Pharmacy, 60th Medical Diagnostics and Therapeutics Squadron, 60th Medical Group, Travis Air Force Base, California. He leads 31 personnel in delivering a \$34.6 million annual budget to 276,000 beneficiaries, executing 309,000 prescriptions each year in support of the Air Force's largest medical center in the continental United States which handles more than 411,000 patient encounters annually. Morcom synchronizes with seven squadrons encompassing 2,500 staff and 450 medical providers, supporting comprehensive community and referral health care, aeromedical evacuation and staging, deployable medical readiness, education, research, and

teleradiology services. He also leads chemical, biological, radiological, and nuclear medical readiness for two wings and 67 units as the Alternate Pharmacy Home Station Medical Response Team chief, aiding delivery of medical assets in various mission critical and contingency situations. Morcom also leads the 60th Medical Group's Combat Service Support Team as the officer-in-charge, providing strategic medical guidance to the 22nd Air Task Force in demonstrating

and evaluating capabilities to generate, employ, and sustain Command and Control and Base Operations Support functions globally. He received a direct commission to the United States Air Force in December 2018 through the Health Professions Scholarship Program while attending Wilkes University's Nesbitt School of Pharmacy in Wilkes-Barre, Pennsylvania. He graduated with his doctor of pharmacy in May 2020.

#### **GENERATION RX AWARD OF EXCELLENCE**

The Generation Rx Award of Excellence was established in 2011 to recognize a pharmacist who has demonstrated a commitment to the mission of substance abuse education.



Anita N. Jacobson, PharmD, is a clinical professor at the University of Rhode Island College of Pharmacy and has worked in direct patient care as a pharmacist in a variety of community and healthsystem settings for over 25 years. She is the director of the Community First Responder Program, which focuses on harm reduction, overdose education, and naloxone outreach, and serves as the hub of the Northeast Rural Opioid Technical Assistance Regional Center. As program director, she has secured over \$5.5 million in state and federal grant funding and leads an interprofessional team of social workers, pharmacists, student pharmacists, and pharmacy technicians to order accredited training programs and

distribute over 55,000 naloxone kits statewide per year in Rhode Island with an additional 3,000 kits sent via mail to rural New England residents.

Jacobson is the coordinator of the Pharmacists Patient Care Laboratories for the doctor of pharmacy program and is an instructor in the doctor of physical therapy program at the University of Rhode Island. Her areas of teaching in the PharmD curriculum include patient-pharmacist communication, physical assessment, SUDs, mental health, cultural sensitivity, health disparities, stigma, health literacy, motivational interviewing, and health care policy.

Jacobson works as a per diem pharmacist at a long-term acute care facility, Eleanor Slater Hospital, for the Department of Behavioral Health and Developmental Disabilities.

She currently serves on the Opioid Fatality Review Committee for the State of Rhode Island and is a former president of the Rhode Island Pharmacists Association, former member of the Rhode Island Board of Pharmacy, and former chair of the Health Disparities and Cultural Competence SIG of the American Association of Colleges of Pharmacy.

#### ANNE BURNS COMMUNITY PHARMACY RESIDENCY EXCELLENCE AWARD

The APhA Community Pharmacy Residency Excellence in Precepting Award recognizes a community pharmacy residency director or preceptor who has demonstrated excellence in precepting, mentoring, leadership, and community pharmacy residency program administration. The award, established in 2003, is intended to recognize pharmacy practitioners who excel as community pharmacy residency directors or preceptors.



Stevie R. Veach, PharmD, BCACP, is a clinical associate professor at the University of Iowa College of Pharmacy and clinical pharmacist at MercyOne Pharmacy in Dubuque, IA. She also has served as the director of the multisite PGY1 Community-based Pharmacy Residency Program at the University of Iowa since 2013. She earned her doctor of pharmacy degree in 2006 from the University of Iowa and completed a PGY1 community pharmacy residency with the University of Iowa and Mercy Family Pharmacy. Veach has precepted introductory pharmacy practice experience students, advance pharmacy practice experience students, and PGY1 community-based residents in the community pharmacy setting for the

past 18 years.

Currently, Veach coordinates the doctor of pharmacy community introductory pharmacy practice experience at the University of Iowa, and she also coordinates and teaches courses focusing on nonprescription medicines and self-care for both doctor of pharmacy and undergraduate students. Veach's primary professional interest is advancing patient care services delivered by pharmacists in the community setting. She has been involved in numerous research and pilot projects related to implementing clinical pharmacy services and practice innovations in the community pharmacy setting and has served as a practice transformation coach for Flip the Pharmacy. Veach is an active member of several state and national professional pharmacy organizations, including the Iowa Pharmacy Association, the American Pharmacist Association, and the Academia-CPESN Transformation Pharmacy Collaborative. Her involvement in APhA has included being a delegate, serving on the APhA Immunizing Pharmacist SIG and Education Standing committees, and regularly volunteering as an abstract reviewer or poster judge for the Annual Meeting Contributed Posters.

In her free time, Veach enjoys spending time with her husband Jeremy and their three children, Landon, Rowan, and Chase. She loves being outdoors, watching her kids participate in multiple sports, and cheering on the lowa Hawkeyes!

Mary S. Klein, PharmD, BCACP, CHSE, is an associate professor of pharmacy practice and director of clinical correlations, practice labs, and simulation at the Texas Tech University Health Sciences Center (TTUHSC) Jerry H. Hodge School of Pharmacy, on the Abilene campus. She

received her PharmD from TTUHSC in 2007 and completed a community-based ambulatory care residency through Scott and White Hospital and Clinics and the University of Texas at Austin in 2008. Klein joined the faculty at TTUHSC in 2008. She teaches in the Immunization Certification Lab, Patient Assessment Lab, and the Pharmacy Leadership, Ethics, and Law course. Klein also practices in primary care on an interprofessional team at Abilene Community Health Center, a federally qualified health center. She served as president of the

Texas Pharmacy Association from 2017 to 2018, on the Tennessee Pharmacists Association Board of Directors in various roles for 12 years, and as their speaker of the House of Delegates in 2010. Gregory A. Fox, BSPharm, is the former health and wellness merchandiser for The Kroger Co.'s Central Marketing Area, encompassing Indiana, Illinois, and parts of Missouri, Michigan, and Ohio. Fox's experience includes community, managed care, long-term care, and consultant pharmacy. He served on numerous health insurance plan boards to promote pharmacist's services. He received his pharmacy degree from the University of Cincinnati and is a graduate of the University of Mississippi APhA Community Pharmacy Business Management Program. He is a former president of the Ohio Pharmacists Association. He initiated and testified for pharmacist services laws in Ohio, Indiana, Illinois, and nationally on the Hill. Fox is currently a member of the APhA Board of Trustees and Executive Committee, serving as its treasurer. Fox served on the Indiana State Board of Pharmacy Technology Committee, the Indiana and Illinois Retail Pharmacy Committees, plus the Medication Safety Partnership of Indiana. telehealth services. She also works with the ONU HealthWise Mobile Clinic that cares for the medically underserved population of Hardin County, OH. She earned her PharmD from the University of Cincinnati and completed a PGY1 Community Practice Residency with the West Virginia University School of Pharmacy and the independent practice site, Waterfront Family Pharmacy. Her professional background includes community practice, ambulatory care practice, and provision of telehealth services. Karen L. Reed, BSPharm, CDCES, CTTS, is director of pharmacy for New River Health, a federally qualified health center, serving four counties in West Virginia. In addition to the oversight of four in-house pharmacies and 10 contract pharmacies, she is the certified diabetes care and education specialist for the center. She is among four pharmacists certified as a tobacco treatment specialist. New River Health was chosen to pilot a program with UVA regarding tobacco cessation with federally qualified health center pharmacists. This was due to the pharmacists' training and involvement prior to the project's inception. Reed began an immunization program with pharmacists and now trained technicians to assist in

improving rates of immunization and our quality scores.

Reed and the other nine pharmacists provide diabetes, cholesterol, and hypertension education completing the first 15 weeks of FARMacy RX for low-income patients identified with chronic diseases. The 2025 session has been approved for funding.

Reed is preparing a program with Target BP to educate patients about hypertension and stroke prevention to begin in February. This will involve multiple disciplines in the organization.

She has two pharmacists leading MTM for patient adherence. Pill packaging is offered at no cost for all patients interested. Reed and the New River Health team believe in using the 340B savings for patient education, healthy options, and adherence monitoring programs.

Reed is a former APhA Board of Trustees member, American Pharmacists' Month spokesperson, and APhA Foundation Capital Campaign co-chair for Women in Pharmacy raising \$250,000 at a grassroots level.

West Virginia University named her to the Inaugural Hall of Fame in 2014 and as an Honoree Women in Pharmacy

She is a former president of West Virginia Pharmacist's Association, Bowl of Hygeia recipient, Kmart Pharmacist of the Year, and in 2023, was named the first recipient of the Thomas E. Menighan Lifetime Achievement Award.

He was later recruited to establish nuclear pharmacy satellites, along with local and remote university externships at New York Hospital and Memorial Sloan-Kettering. He then went on to join IBA Molecular as VP regulatory and corporate radiation safety officer,

later becoming VP operations. For the last 15 years, Soffing has served as associate director and cyclotron RSO of the PET Center at Columbia University.

After receiving his BS in pharmacy from St. John's University, Soffing completed Radio pharmacy-AU Certificate at University of Southern California. He went on to earn an MS in radiation science from Rutgers University, an MBA from NYU Stern School of Business and completed a doctor of pharmacy degree at the University of Florida.

Soffing has been an active APhA member, serving as member-at-large for the Nuclear Pharmacy Practice Section from 2005 to 2007, and spearheaded the creation of the first three live BCNP CE sessions, university-accredited, for the APhA Annual Meeting & Exposition. When elected Nuclear Pharmacy Special Interest Group Coordinator-elect and coordinator from 2013 to 2015, he saw to it that the Radiopharmaceutical Supplier Qualification Tool was completed and ready for publication by APhA by the end of his term. He also serves on several committees for the Society of Nuclear Medicine, maintains plenary membership in the Health Physics Society, and remains a member of ASHP.

Soffing was selected as a member of the New York State Board of Pharmacy in 2021, serving on its USP and MPJE subcommittees.

### Scientific Awards and Honors, Administered by the APhA Academy of Pharmaceutical Research and Science

#### **EBERT PRIZE**

The Ebert Prize, administered by APhA-APRS, was established in 1873. It recognizes the author(s) of the best report of original investigation of a medicinal substance published in the *Journal of Pharmaceutical Sciences* in the past year. Both the Editorial Advisory Board of the journal and the APhA-APRS Awards Committee participate in the selection process.

#### **Endowed by the Ebert Legacy**



**Tze Ning Hiew, PhD,** is an assistant professor at the University of Iowa College of Pharmacy. She received her Bachelor of Science (Pharmacy) and PhD degrees from the National University of Singapore. Prior to graduate school, she completed her pre-registration training at Tan Tock Seng Hospital, Singapore, and subsequently worked as an inpatient pharmacist in the same hospital.

Following her doctoral studies, she joined the Department of Industrial and Physical Pharmacy (now Department of Industrial and Molecular Pharmaceutics) at the Purdue University College of Pharmacy as a postdoctoral researcher, where her research was directed toward exploring how intermolecular drug—

polymer interactions and glass transition temperature affect the physical stability and dissolution behavior of amorphous solid dispersion formulations. She also worked on strategies to increase the drug loading of amorphous formulations through surface modification of particles.

After completing her postdoctoral training at Purdue University, Tze Ning joined the Department of Pharmaceutical Sciences and Experimental Therapeutics at the University of Iowa College of Pharmacy as an assistant professor. Research in her group at the University of Iowa College of Pharmacy focuses on using innovative formulation and processing strategies to address the challenges of modern-day oral drug delivery. Her research is supported by the National Science Foundation, PhRMA Foundation, Roy J. Carver Charitable Trust, as well as the pharmaceutical industry.

Tze Ning has been honored with several awards, including the IPEC Foundation Patrick DeLuca Emerging Researcher Award (2020), the PhRMA Foundation Faculty Starter Grant in Drug Delivery (2024), and the National Science Foundation EPSCoR Research Fellowship (2024). She also serves on the editorial boards of AAPS PharmSciTech and the *International Journal of Pharmaceutics*.

#### **CLINICAL RESEARCH PAPER AWARD**

This award, established in 2006, is intended to promote and encourage high-quality clinical research or practice-based research in the clinical sciences by recognizing an original research article in this area published in *JAPhA*.



**David Jacobs, PharmD, PhD,** is an associate professor in the Department of Pharmacy Practice at the University at Buffalo School of Pharmacy and Pharmaceutical Sciences. Jacobs holds a PharmD from the University at Buffalo and a PhD in epidemiology from the University at Buffalo School of Public Health and Health Professions.

Jacobs' research program centers on improving medication use and health outcomes in high-risk adults and populations experiencing health disparities. His work emphasizes expanding the role of pharmacy in delivering care services and addressing social determinants of health. Jacobs' research has

received funding from the NIH, the Agency for Healthcare Research and Quality, the Community Pharmacy Foundation, and various private foundations. Since 2018, he has successfully obtained 19 competitive grants, serving as principal investigator on 12 and co-investigator on seven. During this period, he has also published 38 journal articles, including 16 as senior or corresponding author and 15 coauthored with a student pharmacist or postgraduate trainee. His independent research focuses on three key areas: 1) developing integrative strategies to enhance care transitions for high-risk patients; 2) implementing community pharmacy practice models to address social determinants of health; and 3) examining factors influencing medication use, health care utilization, and costs among older adults. He has established an interdisciplinary team, collaborating with faculty from medicine, public, and clinical pharmacy, utilizing diverse methodologies, including implementation science, pragmatic trial design, and pharmacoepidemiology.

#### RESEARCH ACHIEVEMENT AWARD IN PHARMACEUTICAL SCIENCES

This award, administered by the APhA Academy of Pharmaceutical Research and Science, encourages and recognizes outstanding meritorious achievement in any of the pharmaceutical sciences. Contributions to be recognized are in the areas of basic pharmaceutical; clinical; and economic, social, and administrative sciences, which develop knowledge and integrate the process of science into the profession of pharmacy.



Delesha Carpenter, PhD, MSPH, is a professor and executive vice chair in the Division of Pharmaceutical Outcomes and Policy. Her research currently focuses on improving patient-provider communication about sensitive issues, like suicide, opioid overdose, and vaccine hesitancy. She also is working to document barriers to community pharmacists delivering harm reduction services, including buprenorphine dispensing, naloxone counseling, and fentanyl test strip sales. She has developed four online training programs to help pharmacists overcome these barriers. She also previously led a research program in inhaler technique education, where she developed an adolescent asthma self-management

app and a tailored video software program to improve children's asthma inhaler technique.

Carpenter directs RURAL-CP, a practice-based research network for rural community pharmacists that has over 150 rural pharmacies across the southeast and is especially interested in improving access to health care services in rural areas. Carpenter has published more than 160 peer-reviewed articles on the topics of harm reduction, pediatric asthma, patient-provider communication, the effects of conflicting medication information on medication adherence, and evaluating the impact of technology on patient outcomes. She has received grants and contracts to support her research from a diverse body of funders, including the NIH, private foundations, industry, and start-up companies. Her research has been featured in The New York Times, National Public Radio, and The Associated Press.

#### WIEDERHOLT PRIZE FOR BEST PUBLISHED PAPER AWARD FOR ECONOMIC, **SOCIAL AND ADMINISTRATIVE SCIENCES**

This award was established in 1996 as the APhA Best Published Paper Award for Economic, Social, and Administrative Sciences. In 2002, it was renamed the Wiederholt Prize in honor of Joseph B. Wiederholt, PhD (1949-2001). Wiederholt was the first recipient of the award and a professor at the University of Wisconsin-Madison. The purpose of the award is to recognize the best paper published in JAPhA within the past 2 calendar years, describing original investigation in the areas of economic, social, or administrative sciences.



J. Douglas Thornton, PharmD, PhD, BCPS, is an associate professor of pharmaceutical health outcomes and policy and the director of the Prescription Drug Misuse Education and Research Center at the University of Houston College of Pharmacy. Before joining the University of Houston, Thornton practiced as a board-certified clinical pharmacist while earning his PhD in health services and outcomes research at West Virginia University, where he also completed his PharmD. He received his PGY1 pharmacy residency training at Saint Mary's Medical Center in Huntington, WV.

Thornton's research focuses on optimizing the management of pain and OUD through effective use of medications and health care services. In 2024, he received the Generation Rx Award of Excellence from APhA for his dedication to SUD education. He currently represents the greater Houston region on the Texas Opioid Abatement Fund Council.

An experienced mentor, Thornton has guided students at all levels within a college of pharmacy. He has directly mentored and supervised eight postdoctoral fellows and seven PhD students, four of whom have graduated, His commitment to training future health care leaders aligns with his mission to improve patient outcomes and address critical challenges in health care.

# Student Awards and Honors, Administered by the APhA Academy of Student Pharmacists

#### **OUTSTANDING DEAN AWARD**

The APhA-ASP Outstanding Dean Award was established in 2005 to recognize the deans of the schools and colleges of pharmacy nationwide who have promoted with distinction the welfare of student pharmacists through various professional activities.



Vassilios Papadopoulos, PharmD, PhD, has served since 2016 as dean of the University of Southern California (USC) pharmacy school, which in 2022 received a \$50 million endowment and was renamed the USC Alfred E. Mann School of Pharmacy and Pharmaceutical Sciences.

Papadopoulos has served as a prominent national voice on the topic of reenvisioning the future of pharmacy education and expanding the role of the pharmacist on the health care team. During his tenure as dean, total enrollment at the school increased by more than 30% with the introduction of innovative new undergraduate and graduate programs and an industry-leading executive sports pharmacy

certificate. The school unveiled a state-of-the-art student center, opened an all-new campus pharmacy with expanded clinical consultation space, and is currently building a community pharmacy and health center in a pharmacy desert area in south Los Angeles. During the COVID-19 pandemic, the school's students, staff, faculty, and alumni played a key role in Los Angeles's mass vaccination efforts.

A noted scientist and innovative leader, Papadopoulos has published over 400 papers, held numerous patents, and served on national and international advisory committees. He is an elected foreign member of the National Academies of Medicine and Pharmacy in France and fellow of the American Association for the Advancement of Science, the American Association of Pharmaceutical Scientists, the Royal Society of Canada, and the Canadian Academy of Health Sciences.

Prior to coming to USC, Papadopoulos served as executive director and chief scientific officer at the Research Institute of McGill University Health Centre in Montreal, and previously as director of the Biomedical Graduate Research Organization at Georgetown University Medical Center, as well as professor and chair of the department of biochemistry and molecular biology. A school of pharmacy graduate of the University of Athens, Papadopoulos holds a PhD in health and life science from the Université Pierre et Marie Curie in Paris.

#### **OUTSTANDING CHAPTER ADVISOR AWARD**

The APhA-ASP Outstanding Chapter Advisor Award was established in 1988 to recognize advisors of APhA-ASP Chapters who have promoted with distinction the welfare of student pharmacists through various professional activities.



Brittany Stewart, RD, PharmD, is an assistant professor (clinical) and the coordinator of Community Experiential Education at Wayne State University (WSU) Eugene Applebaum College of Pharmacy and Health Sciences in Detroit. Stewart has proudly served as the faculty advisor for the WSU American Pharmacists Association-Academy of Student Pharmacists Chapter since 2014. Stewart coordinates the following courses in the third year of the PharmD program: Applied Therapeutics in Self-Care, Community-Introductory Pharmacy Practice Experiences, and The What, How, and Why of Community Pharmacy. Stewart is also the faculty coordinator for the APhA Medication Therapy Management Services

Certificate Training Program and co-coordinator for the Pharmacy-based Immunization Delivery program at WSU. As the APhA-ASP faculty advisor for the past 10 years, Stewart's guiding principle has been to promote the personal and professional growth of student pharmacists through their involvement with the chapter. She has worked to grow the organization and advance the mission of APhA-ASP through innovation, inspiration, motivation, and teamwork with student pharmacists. Stewart established several sustainable community partnerships that have afforded students the opportunity to provide patient care services in the Detroit community. She is an advocacy leader and always encourages student engagement on a local, state, and national level to advance the profession. Stewart leads by example with a strong record of involvement with the Michigan Pharmacists Association, Lambda Kappa Sigma, and APhA. Stewart's favorite event that she attends every year (with students) is the APhA Annual Meeting & Exposition.

Stewart is passionate about mentorship and has worked with numerous APhA–ASP students on impactful research projects that have resulted in successful outcomes such as published abstracts, posters presented locally and nationally, prestigious awards, and student-authored publications. Stewart's "why" is watching students grow and prosper into successful pharmacists.

#### GOOD GOVERNMENT STUDENT PHARMACIST-OF-THE-YEAR AWARD

This award, established in 2004, recognizes a student pharmacist who actively promotes the value of advocating for the profession and organizes student pharmacist grassroots activity within their chapter. Nominees must be active members of the APhA Academy of Student Pharmacists and a state pharmacy association. The government affairs activity for which the recipient was nominated must have raised student pharmacists' awareness of current state and federal issues and made a positive impact on the pharmacy profession.

Lydia Fritsche, BS, is a student pharmacist in her final year at the University of Nebraska Medical Center (UNMC) College of Pharmacy. Throughout her academic career, Lydia has actively engaged in leadership roles within the UNMC APhA-ASP Chapter, particularly in the Student Political Action Network (SPAN) and as a member of the UNMC Student Delegates.

Her commitment to advocating for policies that enhance patient access to health care and pharmacy services has been evident in her roles as UNMC's APhA-ASP Chapter delegate, policy vice president, SPAN Committee chair, and the College of Pharmacy Liaison for the UNMC Student Delegates. In those

roles, she empowered her peers to recognize their potential in shaping their professional futures and the importance of advocating for policies that impact their field.

Alongside her other initiatives, she also introduced a policy aimed at improving patient access to prescription medications. The policy garnered support from her professors and the Nebraska Pharmacists Association and successfully became a Nebraska state law in 2023. An additional component of this law is slated for introduction as a bill in 2025.

#### IMMUNIZATION CHAMPIONS AWARD RECIPIENTS CORPORATION/INSTITUTION

Community pharmacies, hospital pharmacies, long-term care pharmacies, clinics, government entities, corporations, institutions, etc. that have established, facilitated, and/or collaborated with their community to provide services to improve vaccination rates. These entities should address and incorporate key elements of the "immunization neighborhood" within their submitted activities.

#### **NATIONAL WINNER**



ShotRx Health and Wellness Solutions is a family practice and immunization clinic owned by pharmacists Ted and Merica Lyons. The words "Learn. Lead. Love." are found throughout the clinic because that is what this team believes it takes to care for the community. ShotRx services all of west Tennessee but specializes in bringing health care solutions to the communities that need it most. ShotRx was founded in 2021 to address the COVID-19 pandemic. The pharmacist-led teams of ShotRx went throughout west Tennessee conducting town hall meetings and vaccinating at churches, business, schools, and

anywhere they could set up a tent! They expanded their services to include childhood vaccinations and primary care after adding nurse practitioners and medical assistants as part of the team. ShotRx has given over 34,000 immunizations, conducted over 1,200 mobile events and 80 educational sessions for the community focusing on sharing the truth about immunizations.

ShotRx has an innovative model of practice that has been recognized through grants and awards from APhA, Upsher-Smith, national media via Scripps News Network, the Tennessee Pharmacists Association, Memphis City Council, Shelby county government, the Tennessee Department of Health, and Shelby County Health Department. Also, a grant from the Tennessee Department of Health helped fund the purchase of two mobile immunization clinic RVs.

#### **HONORABLE MENTION**



Livingston Pharmacy was established in 1959 by R. Jack Livingston, a World War II veteran who earned his pharmacist license from Duquesne University through the GI Bill. In the 1960s, it set the benchmark for independent pharmacies, featuring a soda fountain and a bowling alley in the basement. Although these amenities are no longer operational, the pharmacy remains one of the longest-standing businesses in the city of Clairton. It was taken over by Jack's son, Robert Livingston in the '80s, and then by Robert's son

Matthew Livingston in the early 2000's. Despite the city's fluctuating fortunes over the past 60 years (much like the independent pharmacy industry), Livingston Pharmacy has steadfastly supported its patients through thick and thin.

#### **HONORABLE MENTION**



Auburn University Harrison College of Pharmacy's Division of Clinical Affairs and Outreach (CAO) is the division of the college that provides direct patient care and clinical outreach. CAO operates four community pharmacies and three interprofessional clinics where faculty, staff, and student pharmacists provide progressive pharmacy services in a collaborative environment. CAO partners with the university, as well as local and state governments and public health agencies to be best positioned to identify and immediately respond to community health needs.

CAO works diligently to bolster vaccine rates by promoting vaccinations, providing vaccine education, and offering individualized vaccine consults. CAO routinely administers thousands

of adolescent and adult vaccines each year, but they are also responsive to acute public health needs. During the H1N1 and COVID-19 pandemics, CAO led vaccine efforts for the campus and community. In fact, through a coordinated, interprofessional effort, 20,000 COVID-19 vaccine doses were administered through this initiative. In addition to local efforts, CAO led the COVID-19 vaccine response for state employees and state legislators.

The department also plays a critical role within the local community. Recently, CAO developed a strategic partnership with Auburn city schools to provide care for underserved youth who were on long wait lists for mandatory school vaccines. CAO was able to utilize the federal vaccines for children program to timely provide these vaccines to avoid missed class days. CAO has also partnered with the Auburn Rural Health Initiative to provide vaccine clinics in rural, underserved communities. Finally, CAO has worked to increase vaccine rates for adolescent vaccines based on state public health priorities.

CAO's has received several recognitions for their vaccine initiatives including two AU Presidential Awards for Collaboration (2023 - Rural Health and 2021 - COVID-19), a 2021 commendation from the Alabama House of Representatives, and a 2014 AU Spirit of Sustainability Award.

#### FRIEND OF PHARMACY

An individual who is a nonpharmacist and has supported, facilitated, or advocated for pharmacists' role in immunizations. Individuals could include a coalition leader, community leader, policymaker, physician, public health official, reporter, etc.

#### **NATIONAL WINNER**



Dave McCormick, BS, is the director of the Indiana Immunization Division at the Indiana Department of Health. In that role, McCormick leads a team of public health professionals committed to eliminating vaccine-preventable diseases by working with approximately 925 health care providers to deliver over \$80 million of publicly funded vaccines. In July 2015, McCormick was elected to the Executive Board of the Association of Immunization Managers, serving as chair in 2019. In 2016, McCormick was elected to the Executive Board of the American Immunization Registry Association and has served as president and chair of the Governance Committee.

#### HONORABLE MENTION



Michelle Fiscus, MD, FAAP, is a board-certified pediatrician and public health advocate who practiced general pediatrics in Franklin, TN, for 17 years before transitioning to a career in public health in 2016. She served as the medical director of the Tennessee Department of Health's Vaccine-Preventable Diseases and Immunization Program and led the state's COVID-19 vaccination efforts until July 2021. Since 2022, she has served as the inaugural chief medical officer of the Association of Immunization Managers, the professional organization of the 64 CDC-funded immunization programs across the United States, territories, and major cities. Through her work at the Association of Immunization Managers, she has

championed pharmacist involvement in immunization efforts, especially for children without access to health care. #### **NATIONAL WINNER**



**LCDR Theresa Castellanos, PharmD, CLC**, is a pharmacist with the U.S. Public Health Service and stationed at Southcentral Foundation (SCF) in Anchorage, AK. She is an integrated clinical pharmacist in a tribal facility that serves 70,000 Alaska Native and American Indian people and has managed vaccine clinics for 12 years. As a vaccine subject matter expert, she developed quality improvement protocols to increase immunization rates and decrease errors. She serves as a preceptor for students, residents of the SCF PGY1 ambulatory care residency program, and trains medical assistants on immunizations and medication administration.

As an APhA-certified immunization trainer, she trained over 45 pharmacists and technicians. In 2013, she implemented the first pharmacist-run flu clinic and now manages several vaccine clinics throughout the tribal system, overseeing over 300 staff members and 10,000 vaccines. During the pandemic, the clinic converted to a drive-through, safely and efficiently vaccinating an average of 40 people per hour.

This past year, she organized a "Boo to the Flu" themed vaccine clinic where staff dressed in costumes and patients received goody bags. She also led other clinics, targeting high-risk populations at the Alaska Native Cultural Charter School, Brother Francis Homeless Shelter, Centennial Senior Housing facility, Covenant House, SCF Elders Program, and the Nutaqsiivik Program, which helps high-risk expecting mothers and their families. For the last 3 years, she partnered with the state of Alaska, Anchorage Health Department, CDC, SCF, and Alaska Native Medical Center to offer free vaccines and administered over 2,000 vaccines in 6 days at the Alaska Federation of Natives Convention, the largest gathering in the nation of Native people to address issues of public policy and government.

Castellanos graduated from Loyola University New Orleans and Howard University College of Pharmacy. She resides in Anchorage, AK, with her husband and two young children.

#### **HONORABLE MENTION**

Joel Thornbury, BSPharm, RPh, a third-generation pharmacist with over 30 years of experience, has dedicated his career to improving health care access in rural Appalachia. As the owner of multiple independent pharmacies, he has been a leader in expanding immunization programs and public health initiatives, ensuring that underserved populations—including school-aged children—receive critical vaccinations. His innovative approach to pharmacy-based immunization has transformed access to care in eastern Kentucky.

Beyond patient care, Thornbury is a tireless advocate for the pharmacy profession. His leadership roles include serving as former president of the Kentucky Pharmacists Association (KPhA) and the Kentucky Board of Pharmacy, where he worked to advance pharmacist services, PBM reform, and expanded immunization authority. Currently, he serves as speaker of the KPhA House of Delegates, where he continues to drive policy initiatives that strengthen the role of pharmacists in public health.

In addition to his work in pharmacy, Thornbury is an active community leader who dedicates his time to numerous civic and service initiatives. He serves on local economic development boards, supporting small businesses and rural health care sustainability. A lifelong advocate for youth programs, he has been involved in mentorship programs, school health initiatives, and regional outreach efforts that promote wellness and public health literacy. An avid marathon runner, Thornbury also champions physical fitness and wellness programs that encourage healthier lifestyles within his community.

Recognized with numerous state and national awards, including Kentucky Pharmacist of the Year and the KPhA Distinguished Service Award, Thornbury has also mentored student pharmacists for over 25 years, shaping the next generation of pharmacists. His unwavering commitment to patient care, legislative advocacy, and community service embodies the spirit of the APhA Immunization Champion Award. His work continues to influence pharmacy practice, health care policy, and public health initiatives that improve the well-being of communities across the region.

#### **HONORABLE MENTION**

Ijeoma Uwakwe, PharmD, MSCR, is a registered pharmacist, a wife, and a mother of four. She is also the owner of WilsonValue Drug Store in Wilson, NC.
