RE: H5427 (McGaw) – PHARMACIES (Includes the COVID-19 immunization under the consent and reporting provisions required for pharmacy administered immunizations to individuals between nine (9) and eighteen (18) years of age.) – SUPPORT WITH AMENDMENTS

Dear Chair Donovan, First Vice Chair Giraldo, Second Vice Chair Potter, and members of the House Health and Human Services Committee:

The American Pharmacists Association (APhA) appreciates the opportunity to provide comments on <u>House Bill (H) 5427</u> (Rep. McGaw), which will expand pharmacists' authority to administer influenza and COVID-19 immunizations to individuals aged nine (9) to eighteen (18). While this legislation is a good start and APhA commends the intent of this legislation, we firmly believe that H5427 needs strengthened to maintain Rhode Islanders' access to **all vaccinations for patients aged three (3) years and older**.

Rhode Island pharmacists, pharmacy technicians, and pharmacy interns under the supervision of a pharmacist have been administering vaccines for the past several years after the U.S. Department of Health and Human Services (HHS) issued a declaration under the PREP Act for

medical countermeasures against COVID-19¹ and then the Third,² Fourth,³ Eighth,⁴ Tenth,⁵ Eleventh,⁶ and Twelfth⁷ Amendments. HHS' declarations and amendments authorized the following:

- Pharmacists (order and administer) and pharmacy technicians and pharmacy interns under the supervision of a pharmacist, to administer to persons ages three (3) or older COVID-19 vaccinations and seasonal influenza vaccines that have been authorized or licensed by the Food and Drug Administration (FDA).
- Pharmacists (order and administer) and pharmacy technicians and pharmacy interns under the supervision of a pharmacist, to administer any vaccine that the Advisory Committee on Immunization Practices (ACIP) recommends to persons ages three through 18 according to ACIP's standard immunization schedule.

The federal authority under the PREP Act preempts state law, and Rhode Islanders have been receiving expanded access to vaccines their local pharmacy personnel provided for nearly five years. While pharmacists (order and administer) and pharmacy technicians' and pharmacy interns' authority to administer to persons ages three or older COVID-19 vaccinations and seasonal influenza vaccines will continue until December 2029, pharmacy personnel's authority to administer other ACIP-recommended vaccines to persons ages three through 18 ended on May 11, 2023. A recent study found there was no difference "of obtaining a timely well-child visit between those who received a routine pediatric vaccine in pharmacies and those who received one in primary care settings",8 which further demonstrates the benefit of increased access to preventive vaccines and health care for children.

APhA urges H5427 be amended to allow pharmacists to continue to administer all vaccines to patients aged 3 years old and older. With these amendments, H5427 will minimize interruptions to patients' access to necessary vaccinations, ensure Rhode Island can meet its public health needs, and save millions in preventable health care costs to the families of Rhode Islanders.

For these reasons, APhA urges the committee to amend H5427 to ensure Rhode Islanders access to vaccines is not interrupted.
